WHY VOTING MATTERS



The right to vote is one of the most important, yet basic rights of the American people. In our democratic government, every person is considered equal and is empowered to use their voice to impact issues on local, state, and federal levels of government.

Citizens over the age of 18 cannot be denied the right to vote based on race, religion, sex, disability, or sexual orientation.

In Indiana, citizens must register to vote. Through our votes, we're able to express our values and make our voices heard on the key issues that affect our lives, businesses, and communities at large, issues like healthcare, taxes, education, and so much more.

YOU HAVE THE RIGHT TO VOTE:

- In a free and fair election
- Privately and independently, in a voting booth that is free from any unauthorized materials
- In an Indiana election, if:
 - You are a U.S. citizen, AND
 - You are a resident of Indiana, AND
 - You will be at least 18 years of age at the next General Election, November 5, 2024, AND
 - You are not currently in prison after being convicted of a crime,
 - You have lived in the precinct where you vote for at least 30 days before the election, AND
 - You are registered to vote.

What to Take with you

A government-issued photo ID, which includes your name, your photograph, and an expiration date which shows that the ID is not expired

Find your Voting Precinct

Once you have submitted and confirmed your voting registration information with the Washington County Voter Registration Office you will need to locate your election polling site. Please contact the Washington County Clerk's office if you are unsure of your voting precinct. The Washington County polling site locations are subject to change but updates will be reflected on their webpage as soon as possible.
